To the student:

By completing and signing this form, I understand and accept the following terms:

- Verification of transferability signifies that coursework completed overseas with a C or higher (or equivalent) will transfer.
- Credit for coursework completed overseas will not be reflected in my overall UMBC GPA.
- Approval of coursework for the major or minor must be obtained from academic advisor. This approval is granted by his or her signature on this form.
- Appropriate departmental approval is required for equivalents to UMBC courses. Review for equivalencies requires a detailed official course description and can take four to six weeks.
- UMBC Residency requirements stipulate that the final 30 credits of my degree must be completed at UMBC. However, if I have earned 90 credits or more, or if my study abroad work will bring me to a total of more than 90 credits, the Office of the Registrar signature constitutes a waiver of the Residency requirement for up to **one** full-time semester abroad. This approval means I am eligible for no further residency waivers upon my return.
- It is my responsibility to check my UMBC e-mail account while overseas to assure that I receive my registration information.
- I have read and understood the instructions for the transfer of my study abroad credit to my UMBC degree program.**
